7 **Call To Order**

8 The meeting was called to order in the Council Chambers at 6:00pm by Chairman K.
9 Johnson with the following Board Members present: Jason Alvarado, Larry Denny, Anna
10 Dodd, C. Johnson, Peggy Maurhoff and Brandon Morris were absent. Also present were
11 Director of Parks and Recreation, Travis Sales, Administrative Secretary, Wendy Young,
12 and Cory Dentler, Recreation Coordinator.

14 **Open Forum**

15 Chairman K. Johnson explained how Open Forum is conducted and asked if anyone in the
16 audience would like to come forth and speak during this time. There being no one wishing
17 to speak, Chairman K. Johnson then closed the Open Forum.

19 **Discuss and consider minutes from the February 4, 2020 Park Board meeting and**
20 **take any action necessary.**

21 The minutes from the February 4, 2020 Park Board meeting were provided to the Board
22 for their review. K. Johnson made a motion to approve the minutes. Alvarado seconded the
23 motion which passed 4-1 (Denny abstaining).

25 **Discuss and consider non-resident fees being waived for children of coaches' in**
26 **Rockwall Baseball and Softball League (RBSL).**

27 Mrs. Leigh Tillman attended the February 3, 2020 Park Board Meeting and spoke in the
28 open forum. She requested that non-resident fees be waived for the children of coaches in
29 RBSL, this fee is \$40.00 per player. As this was in open forum and not on the agenda all
30 the board could do was listen. Per your request, staff has calculated the number of players
31 that this would impact during the 2020 Spring RBSL season. Also, be reminded that this
32 number will change every year in the Spring and Fall as players and coaches change. Staff
33 requests that Park Board consider a recommendation to City Council for their review. After
34 a brief discussion, Denny made a motion to not waive any fees for non-residents even
35 players of coaches and coaches themselves and leave non-resident fees as they stand. K.
36 Johnson seconded the motion which passed unanimously.

40 adjourned at 6:34 p.m.


