Rockwall Main Street invites you to apply for participation in the San Jacinto Street Art Market held the 2nd Saturday monthly from May through October, 2010. Because this is the first year of the San Jacinto Street Art Market we are waiving fees for our artisans. The SJS Art Market will be held in conjunction with our Seasonal Farmers Market located across the street on the Historic Courthouse grounds. The Farmers Market has enjoyed great success with steady streams of customers each Saturday and we believe the Art Market is a complimentary extension. Additionally, we plan to introduce outdoor dining and live music to the Art Market.

Please be sure your application is complete and neatly printed. Submission of an application does not guarantee acceptance. The San Jacinto Street Art Market committee prides itself with offering the community a quality market with a diverse selection. Therefore the Market reserves the right to select vendors who meet the criteria. The San Jacinto Street Art Market committee reserves the right to limit the number of booths in order to avoid excess duplication of specific goods. Considerations may also include longevity and reliability.

For consideration, the following items must be completed and enclosed:

1. Complete Application (Incomplete applications will not be accepted)
2. Notarized Hold Harmless Agreement
3. Photographs of your merchandise and/or display – Digital photos and color photocopies are accepted

Applications and photographs become the property of the Rockwall Main Street. San Jacinto Street Art Market is an open-air market and does not provide shelter from any weather conditions, e.g., sun, rain, wind, etc.

As a San Jacinto Street Art Market vendor, you must register at 7:30 a.m. each day you plan to participate. Vendors are not allowed to set up until they have registered with the San Jacinto Street Art Market representative. Vendor booths must be ready for business by 9:00 a.m. and staffed until the San Jacinto Street Art Market closes at 2:00 p.m. No pets (with the exception of service and/or guide dogs) are allowed with vendors on the San Jacinto Street Art Market grounds at any time.

Market Policies and Rules and Regulations

1. The City of Rockwall will not assume responsibility for damage or theft of your property. Vendor is responsible for submitting all applicable taxes directly to the proper agency. No electricity or water is available. No generators will be allowed. All sale and display items must be contained within assigned area.
 - a. Spaces are 10 ft. X 10 ft.
 - b. Spaces are assigned upon approval of your vendor application
 - c. Vendors may register between 7:30AM and 8:00AM the day of the Market
 - d. Registration booth is located at the corner of San Jacinto and Rusk Streets
 - e. Set up is from 7:30AM until 9:00AM
 - f. No vehicles allowed on San Jacinto Street after 8:30AM, no exceptions
 - g. Tear down is from 2:00PM until 3:00PM
 2. Art Market representatives have the final authority on site to interpret and enforce rules and regulations related to the San Jacinto Street Art Market. Vendors that do not comply with instructions and/or the rules and regulations of the Market will considered in default and may not be eligible for future markets.
 3. Weather policy: The San Jacinto Street Art Market will open the 2nd Saturday monthly unless there is an 80% chance of precipitation forecasted for 8AM on Saturday Market. Market coordinators will use the National Weather Service forecasts and will post Market closings on the Main Street website by 5PM the Friday prior to the Market. The Main Street website is <http://mainstreet.rockwall.com/>. Vendors may also call the Manager at 972.772.6400.
- ❖ Market hours: 9am – 2pm
 - ❖ Market dates: 2nd Saturdays monthly from May through October
 - ❖ Market location: San Jacinto Street between Washington and Rusk Streets
 - ❖ Parking: Vendors may park in the designated parking area: corner of Fannin and Rusk Streets
 - ❖ Smoking is prohibited in the vendor and sales area
 - ❖ Amplified sound is prohibited in the vendor and sales area
 - ❖ Vendors are responsible for supplying their own tents, tables and chairs
 - ❖ Market style tents and umbrellas for shade are encouraged
 - ❖ Dumpsters are not available, vendors are responsible for their boxes
 - ❖ Service animals allowed, all other pets prohibited
 - ❖ Vendor spaces must be clean, if not clean vendors will not be allowed to sell at future markets
