**MINUTES**

7 **Call To Order**

8 The meeting was called to order in the Council Chambers at 6:00pm by Jason Alvarado  
9 with the following Board Members present: Marcia Hasenyager, Jason Alvarado, Vincent  
10 Harris, Jenny Krueger, Michael McEwen and Jake Wimpee. Amanda Fowler was absent.  
11 Also present was Director of Parks & Recreation, Travis Sales, Recreation Superintendent  
12 Cory Dentler Parks Superintendent Brian Sartain, and Administrative Assistant Wendy  
13 Young.

15 **Open Forum**

16 Chairman Alvarado explained how Open Forum is conducted and asked if anyone in the  
17 audience would like to come forth and speak during this time. There being no one wishing  
18 to speak, Alvarado then closed the Open Forum.

19  
20 **Discuss and consider the minutes from the March 4, 2025 Park Board Meeting and**  
21 **take any action necessary.**

22 Alvarado made a motion to approve the minutes, Krueger seconded the motion which  
23 passed unanimously.

24  
25 **Discuss and consider the renovation of Gloria Williams basketball court by the Boys**  
26 **and Girls Club and the City of Rockwall as a Shaq/Icy Hot/Comebaq Court, and take**  
27 **any action necessary.**

28 Mr. Sales explained that the Boys and Girls Club of Rockwall applied for and was awarded  
29 a \$165,000.00 grant to completely renovate a basketball court and since they don't  
30 currently own one they reached out to the City of Rockwall and we agreed to renovate the  
31 court at Gloria Williams Park. The Parks and Recreation Department has secured quotes  
32 for the following projects to meet the grant award specifications:

- 35 • Completely remove and install new concrete basketball court
  - 36 • Install LED court lighting
  - 37 • Install all new black poly coated fence around court including the entire pool since  
38 they are tied together
  - 39 • Install basketball poles, backboards and rims
  - 40 • Install player benches
  - 41 • Install canopies over player benches
  - 42 • Install new branded surfacing on the court per grant specifications


43 After a brief discussion Hasenyager made a motion to make a recommendation to City  
44 Council to move forward with this project. Harris seconded the motion which passed by a  
45 vote of 5-1 (Krueger abstained, Fowler absent).


